IIM Ranchi first among IIMs to offer DigiLocker

Ranchi, (Hindustan Samachar) : IIM Ranchi has become the first among all the 20 IIMs in India to offer DigiLocker facility to the students of 2018-20 batches of MRA-HRM, PCEXP, and Ph.D. Students here can benefit from this facility to collect their rewards digitally on DigiLocker. For this, they will have to create their ID on DigiLocker and can click in the search section of the issue and fill the desired information and download their certificate. The information was given by Pankaj Prasen, Consultant, Jharkhand, SICTM. After IIM Ranchi, now other educational institutions of Jharkhand are also working towards uploading the certificates of students on DigiLocker. Notably, DigiLocker is a virtual locker, started under the Digital India campaign. DigiLocker, an Indian digitization online service, is a flagship initiative of the Ministry of Electronics and Information Technology (MeitY). It aims to 'Digital Empowerment of citizens in the country by providing access to authentic digital documents of citizens. The documents issued here are treated at par with the original physical documents as per Rule 9A of the Information Technology Rules, 2016. The union cabinet in its meeting held on October 27, 2016 had approved setting up of Digital Depository of Academic Awards as National Educational Depository (NED) on the pattern of Securities Depository. A virtual webinar of social officers was conducted today, wherein information was given about the process of uploading the certificate.

'Vaccination should be the priority, Bengal bypolls can wait': BJP's Suwendu Adhikari

Kolkata: BJP MLA and Leader of Opposition in West Bengal Assembly, Suwendu Adhikari on Friday expressed concerns over the COVID-19 situation in the state and stressed that vaccination of all people should be the priority of the state govt over holding bypolls. When asked about the pending bypolls on seven Assembly constituencies, Adhikari said, "Bypolls should not happen at this time. Vaccination should be the priority. Bengal government is reducing COVID cases and showing it below 1000 (daily COVID tally). They are hiding the real data." Interestingly, Suwendu Adhikari had actively taken part in several rallies for the 2021 West Bengal Assembly elections which took place during the peak of the second COVID-19 wave. Shifting focus to the BJP's complaint in the Assembly seeking

disqualification of TMC MLA Mukul Roy, Adhikari said, "We will receive order copy on Monday. We don't have any hope from the system." "We are planning to go to court in August. The Speaker should complete the matter in time and decision should come, that's our demand," he added. Meanwhile, the West Bengal government has decided to extend the partial lockdown conditions till August 15. Although there has been some relaxations, however, local trains have not been allowed under the present condition. According to a notification issued by the Mamata Banerjee government, all government programmes have been allowed to continue indoors with a 50 per cent seating capacity, while the state-wide curb on the movement of the people and vehicles between 9 p.m. and 5 a.m. will continue.

Bommai Has Full Freedom to Pick His Team, Will Not Intervene: Yediyurappa



New Delhi : Former Karnataka Chief Minister H S Yediyurappa whose resigned last week after months of internal turmoil in his cabinet on Friday reiterated that he will not intervene in the selection of ministers in the new cabinet. Stating that he will continue to work towards strengthening the party, the veteran BJP leader said that his successor and new Chief Minister Basavaraj Bommai is free to pick his team in consultation with the party leadership. He visited the district to console the family of his son, who had allegedly committed suicide pained by his resignation as CM, here on Friday. "Bommai is in Delhi today, in a few days he will discuss with the central leaders and decide on who should be in his cabinet. I will not intervene on who should be made minister or not. Bommai is completely free, he will discuss and choose his cabinet ministers. I will not give any suggestions on this," Yediyurappa said. Speaking to reporters, he said his advice to the new Chief Minister is to do a good job and that Bommai has already made announcements aimed at helping the poor and the downtrodden. To a question on inducting legislators who had joined BJP after quitting Congress-JD(S) coalition in 2019 and had helped the party to power, the 78-year old leader said, it is left for

Narendra Modi, Union Home Minister Amit Shah and BJP national President J P Nadda. He said, after Ganesh Chaturthi (September 10) he has decided to visit a district every week and organise karyakartas to strengthen the organisation. Yediyurappa later visited the family of his fan Rajappa (Ravi) at Bommalapur in Gundlupet taluk, who had allegedly committed suicide pained by his resignation. "I'm pained by the step he took, this should not have happened. He has a mother and two sisters and was not married, taking care of his family is my responsibility, so I have given Rs 7 lakh to his mother, will put another Rs 5 lakh to their bank account and see to that they get interest, will see what else is to be done for them," he said. Pointing to the welcome he received on his arrival in the district, the former Chief Minister said this is the best example of the love and affection of the people, despite not being in power. To a question that many party workers are upset about his resignation, he said, "power is not permanent, I have done this (resigned) to nurture a capable person in front of my eyes and to make way for others. A capable person like Basavaraj Bommai is the Chief Minister today." Noting that Bommai was unanimously elected as his successor, he said, "he has completely confirmed that good works will happen under his leadership."
